USA: New website cuts out medical tourism agents

MediBid.com - A new US based website "connecting" Drs & hospitals all over world to their patients. Participating physicians can expand their practice by offering medical services to cash paying patients without what the company calls interference from the medical middlemen who drive costs skyward without improving care. MediBid allows doctors to set their own prices based on the patients' needs and gives patients a choice. Physicians tailor bids on a case-by-case basis, which empowers them to find new patients and enhance their practice. MediBid does not regulate prices.

BAHAMAS: Bahamas seeks to develop medical tourism



The Ministry of Tourism is seeking to develop an investment incentives policy for the healthcare industry, similar

to that presently enjoyed by the hotel industry. The authorities feel that to establish the Bahamas as a medical tourism destination, it is not sufficient just to open and let the world know. American medical institutions are being targeted by the Grand Bahamas Port Authority (GBPA) for its proposed \$100 million hospital for Freeport. The benefits to be derived might include creation of specialized health services such as kidney transplants, cardiac surgery, orthopedic surgery, pediatric surgery and cancer therapy.

MEDICAL TOURISM / KOREA

Seoul City intends to boost tourism as one of its top priority tasks for 2010, and the metropolitan government is ambitiously seeking to attract 10 million foreign tourists this year. It is seeking to boost the medical tourism industry, and hopes to increase the number of medical tourists to 52,000 from 37,000 recorded in 2009, out of a total of 50,000 for all South Korea. For 2010, it seeks to attract 1.8 million Chinese tourists. Last year, 1.34 million Chinese people visited Seoul. In 2010, Korea is expecting to attract around 60,000 medical tourists and the target is to attract 140.000 in 2015.

Korea's cosmetic surgery clinics are packed with foreign patients. In the past, the patients were largely from China, Hong Kong and Singapore, but recently they have diversified and now they come from Indonesia, Saudi Arabia, the UK and the USA Medical tourism has increased rapidly

as the quality of medical treatment in the country improved and the Korean won weakened against other currencies in early 2009. Foreign patients in Korea reportedly spend twice as much money as regular Japanese tourists.

MEDICAL TOURISM / CUBA

Cuba is aware of the value of tourism to its economy and what a change in US tourism policy would mean. This nation has rapidly developed hotels and resorts over the past two decades to cater to primarily Canadian and European travellers, 2.4 million tourists in 2009. Cuba has been offering health tourism since 1989, for both medical treatment and health spas. All health tourism goes via Cubanacan Tourism and Health, a state owned company that uses a network of hospitals, private medical and dental clinics, opticians, drugstores and spas. It markets health tourism through travel agencies and private clinics. It runs the international clinics scattered all across the country, as well as medical outposts in hotels and resorts.
