"One of our goals is to establish cooperation throughout the industry with certain standards, such as adequate



translation services, appropriate transfer of patient records back and forth, and competent pre and post medical care."

What makes you different from the other medical travel websites?

COSTA RICAN Medical Care applies to ProMED Costa Rican Medical Care (CRMC), a medical tourism agency specializing in medical and dental procedures performed exclusively in Costa Rica, has applied for membership with ProMED, the Council for the International Promotion of Costa Rica Medicine. not-for-profit ProMED, private organization, а coordinates the quality control and international promotion efforts of medical providers and the government. Its goal is to ensure the quality of services provided by the private health industry in Costa Rica when promoting medical tourism.
